Our parenting class has a section of its agenda which also focuses on nutrition. The number of guest that came to the center was 39,163 over a 231 day period, covering this current fiscal year. For many of our guests, our morning meal is the main meal of their day. We also celebrate cultural and national holidays with special meals.
