DUE TO THE FREQUENCY OF ON-SITE MEETINGS AND OTHER WORK, IT WAS COST EFFECTIVE TO PROVIDE A HOUSING ALLOWANCE TO THE PRESIDENT, WHO AS A DIRECTOR IS ALSO EXPECTED TO MAINTAIN A RESIDENCE IN HIS HOME REGION. THE VALUE OF HOUSING IS REPORTED AS TAXABLE COMPENSATION. THE HOUSING ALLOWANCE TO THE PRESIDENT WAS DISCONTINUED AS OF AUGUST 1, 2018.
