

Work supported by the US Department of Health and Human Services, the US Department of Education and the National Institute of Justice. OSLC conducts scientific research to understand family, peer, school, community and individual processes that influence the long-term behavioral and psychological outcomes for children, adolescents and adults. The organization has an international reputation for the theory, design, implementation and evaluation of interventions that improve the well being of individuals and families. The translation of theory to evidence-based practices include innovative methods, longitudinal studies of the general population, at-risk children and families, and rigorous evaluation of our programs. Examples of some of our evidence based programs include those with children in high-risk schools, children in foster care, the juvenile justice system, divorced families, and incarcerated parents. Research findings are published and disseminated to benefit professionals in psychology, social work and education.

Work supported by subcontracts. An important aspect of our research is a collaboration with others in the field of child development, prevention research and the application of research to practice. Upon completion, the audit Committee approves filing of Form 990 and reports such action to the Board of Directors. Draft copies of Form 990 are provided to the Board members prior to filing.

In addition to declaring a conflict on matters before the Board, the Directors file a written disclosure annually. Scientists report significant financial conflicts of interest annually. These reports are reviewed by administration and a board subcommittee. Where conflicts are identified, written management plans are signed by administration and the Scientist.

The top management officials' position is included in a market-based job grading system where ranges of pay are associated with levels of job responsibilities and required education and job knowledge of the employee.
