Artists-In-Residence: Kala's artist residency program includes 24 hour a day access to Kala's printmaking workshop and media center. Artists come to Kala's studio to create work in a variety of techniques ranging from letterpress, intaglio, screenprint, lithography to photography and digital media. Each artist will donate one work of art to the gallery and print archive.

Educational & Community: Kala's education programs include over 100 adult workshops each year in a range of techniques from printmaking to painting, photography, media arts, and professional practices. Youth art education programs include Artists-In-Schools programs and on-site programs like summer art camp, after school art studio, field trips for local public schools, and teen studio workshops. Additional programs include exhibitions and public programs including artist talks, film screenings, panel discussions, and performances.

In addition, the Organization was informed, in a letter dated March 8, 1977, that it is exempt under Section 23701(d) of the California Revenue and Taxation Code.

The Organization, effective September 18, 2018, received notification from the Internal Revenue Service indicating the it is exempt under Section 501(c) (3) of the Internal Revenue Code and that it is no longer exempt under the group exemption granted to Advaita.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Organization and recognize a tax liability or asset if the Organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or the Franchise Tax Board. Management has analyzed the tax positions taken by the Organization, and has concluded that, as of September 30, 2018, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Organization is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in question. Management believes it is no longer subject to tax examinations for years prior to September 30, 2013.
