Psych Serv-PTV served approx 300 clients during the year. PTV provides psych evaluation, individual & family therapy, reducing depression and PTSD, enhance functioning of families. PTV refers clients to our pro-bono psychiatrists for eval & follow up with continued consultation and collaboration with the psychiatrist. PTV holds asylum readiness groups to prepare our clients for the asylum process. Healing Club is a multi-cultural gathering of our clients and families with PTV staff for peer and recreational activities. It provides the opportunity to share their culture through food, music, stories, and build a sense of community and social support and to share their personal challenges and achievements.

Medical Care - Most survivors of torture, who are new to the U.S., are not eligible for government, or workplace health coverage the first year of residency, and many require immediate medical care due to injuries caused by human rights abuse or due to untreated chronic conditions. PTV provides free outpatient medical care at our offices inside Eisner Health, including referrals to medical specialists, such as neurology, psychiatry, and gynecology. PTV provides immediate care by physicians specializing in trauma, and refers to specialists at Eisner Health and other local health care organizations, at no cost to our clients. Emergency or trauma-related dental care is available through our partnership with Change A Life Foundation.

Case Mgmt Services-PTV coordinates with staff, pro-bono professionals and other community resources to assist and respond to our clients' basic & emergency needs, on the path to them becoming self-sufficient. PTV Clinical Director, clinical staff, Medical Director, Case Managers meet weekly for case conferences, assigning & planning for clients, case review, lectures, and review articles & films that are relevant. We coordinate our resources to help assist our clients with clothing, food, emergency financial needs, transportation, housing, legal services, and job preparation. This includes an on-site food bank, grocery gift cards, bus tokens, housing assistance, emergency shelters, transitional housing programs, and job training.

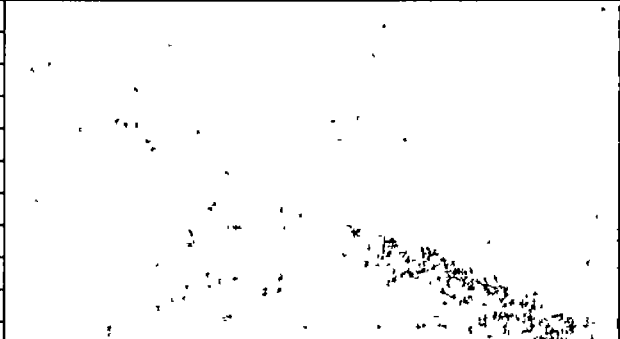
