OTHER PROGRAMS Other Programs include East-West Center in Washington, External Affairs, and the Auxiliary enterprise services. East-West Center in Washington supports the Center's mission through direct work with U.S. policymakers and opinion leaders in the nation's capital. It facilitates understanding of the U.S. policy process by its Asia-Pacific participants through direct interaction with U.S. policymakers. It also continues the successful Asia Matters for America/America Matters for Asia initiative to organize and disseminate information, data, and analysis on U.S.-Asia interactions that included Korea Matters and Indonesia Matters for America publications. The office held over 40 public seminars and events, continuing engagement with members of Congress and their staffs on Asia-Pacific issues and hosting visiting fellows from China, Thailand, Mongolia, and Uzbekistan, as well as hosting 22 undergraduate and graduate interns from across the U.S. and Indo-Pacific region. External Affairs office hosted 30 public seminars and major community events on key issues and coordinating 51 briefings for visiting U.S. and foreign leaders, policy makers and other dignitaries and the EWC Alumni Conference in Seoul where more than 400 alumni came together for panel discussions on topics covering the region and key speakers addressing issues of the Region. Auxiliary enterprises provide conference facilities and dormitory housing for students and conference participants that participate in the Center's programs.

Form 990, Part III, Line 4a:

Since 1960, the East-West Center (Center) has a long and proud legacy promoting better relations and understanding among the people and nations of the United States, Asia, and the Pacific through cooperative study, research, and dialogue. The Center serves as a resource for information and analysis on critical issues of common concern, bringing people together to exchange views, build expertise, and develop policy options. As a national, public diplomacy institution, the Center works in partnership with more than 1,000 organizations throughout the United States (U S) and in the region. The collaborative research, education, seminars and outreach, and other programs bring together Americans and counterparts from Asia and the Pacific to work in an atmosphere of academic freedom on issues of mutual importance. The Center's exchange and dialogue programs involve multi-country, region-wide activities involving everyone as full participants. There were 3,416 participants taking part in the Center activities throughout the region. While more information on the Center and its programs may be found at our website (www.EastWestCenter.org), the following is a highlight of the program activities during the year.

PROFESSIONAL DEVELOPMENT PROGRAM The Professional Development Program conducts all of the Center's short to medium term capacity-building, leadership training, professional exchanges, career development, and high-level dialogue activities. The Center has developed the most extensive program of trans-Pacific journalist and editor exchanges in the region, with exchanges for the Asia Pacific region as a whole (Jefferson Fellows). Close to 1,100 U S and international journalists, young leaders, women entrepreneurs, and smart city development experts from more than 40 countries participated in 16 study tours, workshops, dialogues and conferences. In June 2018, some 350 journalists and media professionals from several dozen countries attended the three-day 2018 East-West Center International Media Conference on theme "What is News Now?" in an era of profound media industry disruption. Forty-nine mid-career professionals in two cohorts from Oceania participated in an 11-week Pacific Islands Leadership Program. There are now 149 PILP alumni. The North Pacific Women's Action Program helps women from the Federated States of Micronesia, Republic of the Marshall Islands, and Palau to more effectively tackle community concerns.

Form 990, Part III, Line 4b:

RESEARCH PROGRAM The East-West Center's Research Program supports the Center's mission by engaging the research and policy communities in the Asia Pacific region on issues of shared concern. Researchers contribute expertise to broad and well-established networks of specialists and institutional partners, leading collaborative and interdisciplinary research on the evolving challenges of a dynamic region. They also provide insights and analysis to the Center's professional exchange, education, and public outreach programs, including its work with the media. The Program hosted 24 visiting fellows, scholars, and officials and hosted 27 speakers in the Noon Seminar Series. In addition, the Program organized and hosted 10 conferences and workshops, and published 13 East-West Wires Seminar Series. The Pacific Regional Integrated Sciences and Assessments (Pacific RISA) team wrote the chapter on 'Hawaii and the US-Affiliated Pacific Islands' in Volume II of the Fourth National Climate Assessment. Released in November 2018, this is the most significant US report to assess the effects of climate change on the U.S. economy and communities. The Center also finalized the AIDS Estimation Model (AEM) 4.14. Twelve Asian countries use the AEM as the basis for their national models; the Center continued to work extensively with these countries on the applications of AEM to Global Fund grants, national strategic planning, development of investment cases, and other scenario analysis to inform national responses. The Center quantified the rate, extent, and socioeconomic importance of forest recovery in Nepal over the last twenty-five years. During this period forest cover doubled to more than 40% of national land area. The project team also modeled the physiographic and socioeconomic variables associated with tree-cover change and quantified their respective influences. The Center hosted the eighth annual North Pacific Arctic Conference, bringing together participants from 8 near-Arctic countries to examine social, economic, and political impacts of sea ice melt in the Arctic.

Form 990, Part III, Line 4c:

EDUCATION PROGRAM The Center is at the forefront of educating people of the Asia Pacific region to meet the evolving demands of global change. The Education Program focuses on community building at the campus level as a stepping-stone to community building at the regional level. The participant's experience is one of grassroots relationship building, cultural exchange, shared experiences, and communal preparation for future leadership roles throughout the region. The Program offers educational opportunities for future leaders in the Asia Pacific region and the U.S. in an era of increased social, economic and technological interdependence. Graduate degree scholarships and certificate programs prepare students and professionals to address the challenges and complexities of the world's most dynamic region. Undergraduate degree scholarships build and strengthen the base of future leaders in the South Pacific. The Program also provided professional development programs for educators to strengthen the capacity of individuals and institutions to cultivate in their students an appreciation and understanding of the histories, cultures, and contemporary issues of the Asia Pacific. The degree student programs remain central to the Center's mission. In FY 2018, there were 343 graduate degree students and affiliated scholars from 41 countries living in residence or on scholarship. The Program accomplishments included continued training of future leaders in the Southeast Asia Youth Leadership Program, Asia Pacific Leadership Program (APLP), and college and K-12 educators through the AsiaPacificEd Program and the Asian Studies Development Program (ASDP).
