MHC IS A NONPROFIT ORGANIZATION WITH STATEWIDE RESPONSIBILITY. MHC COLLABORATES WITH ORGANIZATIONS AND INDIVIDUALS TO INSPIRE COMMUNITY CONVERSATIONS, FORGE CONNECTIONS, AND STRENGTHEN AUTHENTIC, DIVERSE VOICES ACROSS MINNESOTA, ESPECIALLY THOSE LEFT OUT OR MARGINALIZED.
