Lincoln County Farm Bureau is the largest contributor to the Sale of Champions. Several members of our Farm Bureau Board of Directors were present to lend Farm Bureau support to these kids. Directors Larry Sasser and Perry Spencer were on hand to bid on behalf of the county Board of Directors. Lincoln County Farm Bureau recognizes the need for the continued support of these fine young people and pledges to do all they can to further benefit the organization of the Lincoln County Farm Bureau.
