THE COUNCIL HONORS OUTSTANDING PROJECTS, INDIVIDUALS, AND ORGANIZATIONS WHO HAVE CONTRIBUTED TO THE COUNCIL AND ITS PROGRAMS RECIPIENTS OF THE HUMANITIES TEACHER AWARDS ARE ALSO RECOGNIZED FREQUENTLY, GUESTS FROM THE NEH, FEDERATION, OR MEMBERS OF CONGRESS ARE PRESENT AT THIS SHOWCASE FOR THE WORK OF THE PUBLIC HUMANITIES HUMANITIES TEACHER AWARDS EVERY FALL FOR ARTS AND HUMANITIES MONTH, THE MHC
