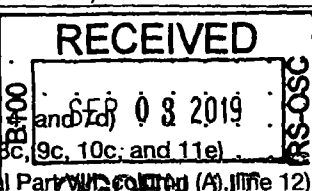

At our refuge in Matamoros we care for up to 20 perons who are ill and abandoned. We ~~has~~ have a class of up to 16 children to assist them through high school. We distribute up to 200 wheelchairs each year. Dr. Rodriguez Cox attends to up to 200 patients who are chronically ill. We assist up to 60 children who have been rescued by the Matamoros government and placed in a children's home.

Our medical director makes free consultations for up to 200 persons living outside our refuge who are chronically ill.*
