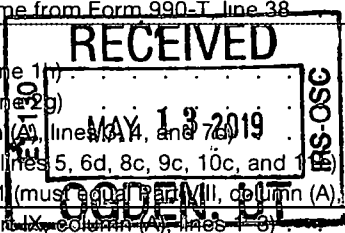

The salary scale is reviewed on an annual basis with special consideration regarding an annual cost of living increase.

At that time they receive a full written packet of library policies, Board policies and other relevant information. These policies are reviewed annually by the appropriate Board committee and, if it is recommended that a policy be changed, the policy change is reviewed and approved or rejected by a full Board vote. Financial reports, program updates and committee reports are distributed at Board meetings and discussed by Board members. Policies, program reports and certain financial reports are available to the general public.
