TO THIS END, MRC SELECTED A DEVELOPER OF AN EMERGING TECHNOLOGY, FIBERIGHT LLC, TO OWN, DESIGN, FINANCE, CONSTRUCT, AND OPERATE A WASTE PROCESSING FACILITY ON A SITE PURCHASED BY MRC ON BEHALF OF ITS MEMBER MUNICIPALITIES. DURING 2016, MRC ENTERED INTO MUNICIPAL JOINDER AGREEMENTS WITH SOME OF ITS MEMBERS TO PROVIDE THE NEW FACILITY WITH MUNICIPAL SOLID WASTE OVER A 15-YEAR INITIAL TERM STARTING IN 2019. MEANWHILE, MRC HAS COORDINATED THE DISPOSAL OF ITS MEMBERS' MUNICIPAL SOLID WASTE DISPOSED AT OTHER WASTE FACILITIES WHILE OVERSEEING THE CONSTRUCTION OF THE NEW WASTE PROCESSING FACILITY.
