Support for Park Activities: We doubled the size of our Baxter Youth Conservation Corps, which hired 20 local youth and four adult leaders to work on trail maintenance projects in Baxter State Park. Crew members installed 100 stepping stones, built seven bog bridges, blazed 6.2 miles of trail, and completed more than 14 miles of trail corridor definition work. Our Patten crew also built an entirely new 1.5-mile trail on land owned by Baxter State Park in the town of Mount Chase. In total, our crews provided 1,805 hours of donated trail services to Baxter State Park.

4b (Code:) (Expenses \$ 47,873 including grants of \$ 0) (Revenue \$ 3,372)

Education and Outreach: We offered the 10th annual Maine Youth Wilderness Leadership Program, which enables ten high school students to experience a nine-day wilderness program, learning from specialists in science, art, storytelling, writing, history, and recreation. Our goal is to cultivate and inspire the next generation of wilderness leaders. Other Education and Outreach activities include publishing our quarterly newsletter (5,200 copies distributed annually), publication of the 2019 Baxter State Park calendar, hosting five trips to Baxter State Park, and offering educational talks and displays at four public festivals and events.

Advocacy for the Park: We attended and participated in three meetings of the Baxter State Park Authority, three meetings of the Baxter Park Wilderness Fund, six meetings of the Katahdin Collaborative, four management planning meetings for Katahdin Woods and Waters National Monument, one Land Use Planning Commission hearing, and nine meetings of the Appalachian Trail Task Force. We carried out a "Finish Well" campaign to Appalachian Trail thru-hikers, including printing and distributing 1,000 posters to venues along the 2,180-mile Appalachian Trail corridor. We funded distribution of brochures and outreach materials through the Maine Tourism Association.
