Operation of Anne Marie House in Hudson, NH, at which up to 10 families at a time receive secure housing, healthy meals, financial literacy education, parenting skills training, case management guiding them toward career and savings goals, assistance in securing reliable transportation, and other support services. Renting a parsonage from a local church and subletting it to a family that has graduated from the residential program.

The Sisters of the Presentation of Mary rents to FPSNH its building, Anne Marie House, at less than full market rent. This in-kind support is estimated to be worth \$143,400 in 2018. They share our mission to serve the homeless.

A professional in finance provided financial literacy training without charge, and a professional in parenting education provided parenting skills training without charge, at a combined estimated in-kind value of \$2,888 in 2018.

Grants to guests were made to either obtain vehicles for transportation to work (our area lacks public transportation) or to attend college or career-advancing courses.

Our area has no public transportation so a vehicle is necessary for guests to get to work. Case management staff follow up with any guests who receive funds directly to ensure funds are used for the intended purpose. Tuition grants may be paid directly to the course offerer; funds for books or college supplies generally go directly to the guest, with follow-up by staff.

Part III, Line 3 - Small "loans" of \$200 or less are made from time to time to residential guests. Guests are not required to pay back the loan, but sometimes they do. Staff work with families to improve financial literacy, increase "rainy day" savings, and avoid the need for future loans.

\$19,347. The corrections in Part X Column A comprising this change are: Line 10c was increased by \$4,338 due to a correction to
depreciation; Line 16 was increased by \$4,338 for the same reason; Line 26 was decreased by \$15,009; Line 27 was increased by \$10,347;
Line 28 was increased by \$3,000. While Line 33 was increased by \$19,347, the Net Assets or Fund Balances (Line 34) only increased by
\$4,338 due to corrections to 2017.
