In 2018 we distributed free food to nutritionally insecure individuals and families in our area. We purchased food from the Vermont Foodbank and from local vendors. Local residents and organizations donated additional food to us. We also distribute USDA foods and supplemented those distributions with donated and purchased food from our shelves since the recipients are among the poorest of our clients. We raised funds for this program through donations, special events, and sales of donated goods in our thrift store. We do not record revenue by program due to the multiplicity of sources and the volume of cash donations. Grants reported here are measured by the cost of food purchased. See Schedule I, Part III for the measure of grants based on retail value of the food distributed.

4b (Code:) (Expenses \$ 45,475 including grants of \$ 30,765) (Revenue \$)

We assisted clients who met our income guidelines with payments for rent, fuel, and utilities. We work with our clients to ensure that they have access to all available benefits from government and private sources. We raised funds for this program through donations, special events, and sales of donated goods in our thrift store.

We do not record revenue by program due to the multiplicity of sources and the volume of non-cash donations.

We distributed a complete holiday meal in December to 214 individuals who met our household financial guidelines for assistance. The food is donated or purchased by us and delivered by volunteers. Our volunteers also deliver donated toys to any children in the families that we serve.

We make monetary and food grants to those residents who meet our income eligibility standards. Applicants complete a paper application, which is reviewed by the Executive Director.

who then holds an interview and records the results on the application. All paper applications are kept on file for a minimum of three years.

Utility, fuel, rent and crisis assistance are all paid by check on the applicant's behalf to local creditors. Food assistance is of perishable, non-perishable, and frozen foods that are given

directly to the applicant. We maintain supermarket style food shelves from which we distribute the food. We measure the value of food distributions with reference to retail food prices

in southeastern Vermont markets.

All assistance is loaded on a digital spreadsheet to show the number of recipients and the dollar value of assistance, and is kept along with the paper applications for at least three years.

All funds are distributed from a checking account maintained by the Executive Director and overseen by the Treasurer. A summary of grants distributed is given to each director monthly

and is printed in the annual town records for each town that we serve.

We operate a thrift store that sells used books, clothing and household goods, all of which were donated. We do not value donations when received, but reflect the selling price as revenue at the time of sale. We sold \$198,895 of such merchandise in 2018 in our thrift store and at rummage sales. Our total cost basis in inventory at the beginning and at the end of the year was zero.

Line 19:

Our primary mission is to distribute free food to individuals who meet our income guidelines and who cannot afford to buy food. We receive multiple donations of food from organizations, businesses and individuals and we buy food from local suppliers. We do not record a value for donated food but instead record a value for food as it is distributed based on current local retail rates. In 2018 we distributed food with a retail value of approximately \$153,072. Our cost of that food was approximately \$32,351.
