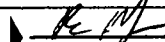

At the end of 2017, we showed a receivable of \$26,294. This represented \$21,054 in grants awarded but not received by Migrant Justice, an organization for which we acted as fiscal sponsor, and \$5,240 in administrative fees owed us by Migrant Justice. Our fiscal sponsorship of Migrant Justice ended in November 2017, when they obtained their own 501(c)3 status.) In 2018, we decided to forgo the \$5,240 owed us by Migrant Justice, erasing that debt as a grant in support of their work. The remaining \$21,054 was a bookkeeping error, and is being deducted from our net assets for 2018.
