

- Membership Appreciation Day. A day where the organizations provides free lunch and dinner to attending members. (\$2120)
- Scholarship Breakfast is held yearly to award scholarships to qualified college-bound individuals. Breakfast meal (\$800). Scholarships (\$3100)
- May-Day is observed yearly to celebrate Polish Constitution Day. This event includes flag raising at City Hall followed by a few guest speakers and a meal at the organizations facility (\$1464).
- Memorial Day is celebrated to honor members that have passed in the previous year. An Honor-Guard plays taps a military salute is performed, (\$449)

The organization conducts numerous functions scheduled around Holidays for adult members and children of members.
Kids functions include a pumpkin-carving night, a Halloween Party, an Easter egg hunt and a Christmas party where all attending children are provide and lunch followed by a grift presentation by Santa (\$1320)
Adults events included free food and entertainment. Those events include a St. Patrick Day dinner, a Labor Day cookout, a Christmas and New Years Eve party. (\$2411)
At various times during the year the members organize and participate in cribbage / 45 / pinochle nights. (28 times in 2018) (\$600)
Our Lounge area is used by members to watch all of the major sports events. Free food is available base ball opening day and every game the local pro-football team plays. (\$510)
