The Bureau received and evaluated 3,283 suspected insurance fraud referrals from the insurance industry, members of the public and other sources, of which 1,358 referrals were accepted for further investigation, resulting in 933 new investigative cases. After initial investigation, 816 cases were closed without criminal prosecution due to insufficient evidence of a crime.

The Bureau referred 256 cases to federal, state and local prosecutors during the year, and supported those prosecutors in the location of witnesses, witness interviews, delivery of subpoenas and additional investigation. 257 individuals were initially charged with insurance fraud and other crimes during 2018, and court cases involving 195 individuals reached a final disposition.

The Bureau conducted an industry training seminar on fraud prevention and awareness for insurance agents, and made insurance fraud presentations at numerous local, state and national training venues.
