#### Statement 8

As set forth in Part I, line 16c, compensation was paid to Matthew MacDonald for his time and effort overseeing the investments of the organization. Matthew MacDonald is a disqualified person with respect to the organization, as a Director of the organization and its Chairman, President and Treasurer. This payment qualifies as an exception to the self-dealing rules as set forth in Trea. Reg. 53.4941(d)-3(c) because the compensation is payment for personal service which are reasonable and necessary to carry out the exempt purpose of the organization and is not excessive. Investment matters attended to by Mr. MacDonald included coordination with outside investment advisors, development of asset allocation and investment strategies, and maintenance and oversight of investment bank accounts. The organization determined that the compensation is not excessive by paying a similar amount that the organization would pay for similar services to a third party, and the compensation was approved by the directors on October 9, 2018 by written resolutions.
