 DISCOVERY DECK: In 2018, the Discovery Deck, an interactive, educational exhibit showcasing the maritime industry of Newport and Narragansett Bay was opened. Hands-on activities include a block and tackle station, maker space, energy grinder and sand table. Program partners, Clean Ocean and IYRS, have educational exhibits on display as well.
