Our mission is to create art and promote artists that inspire personal, political, or spiritual awakening. Our programs include an emerging artist art gallery, music recordings, music and multimedia performances, experimental and educational filmmaking, public sculpture maintenance, and summer programs for at risk youth.

Our emerging artist gallery presents 30 exhibitions of group works and 30 solo exhibitons each year. The exhibitions provide the first gallery experiences for many artists. The exhibitions also provide mentoring in presenting work to a gallery, hanging work properly, pricing work, and marketing their exhibition. The exhibitions also provide performance space for 6 musical performers at each exhibition. The gallery's artist studio program includes private studio space, mentoring in arts business and management, and work experience in all aspects of the gallery's artistic community. The gallery also offer a summer program for at risk youth that provides experience in music production, painting, set design, and many othe rmediums.

4b (Code:) (Expenses \$ 7,736.94 including grants of \$ 5,500.00) (Revenue \$ 5,500.00)
Our music and performance programs include recordings and performances. This year we presented the acclaimed jazz/classical artist John Hollenbeck's Claudia Quintet on a festival tour in Canada. Hollenbeck is a composer of music uncategorizable beyond the fact of being always identifiably his. A conceptualist able to translate the traditions of jazz and new music into a fresh, eclectic, forward-looking language of his own invention, intellectually rewarding yet ever accessibly vibrant.
We also worked on a Caesar Pink directed studio recording of experimental music that mixes many musical genres while presenting political commentary in the form of social satire. Among the artist who worked on the project were avant garde pianist Mike Garson, and guitarist Reeves Gabrels.

Among our programs is the restoration of the Stargazer pubic sculpture in Long Island, NY. The sculpture was damaged in Hurricane Sandy and after the death of designing artist Linda Scott was left to deteriorate. Arete Living Arts is fnding the repair and restoration of the work, to be completed in the summer of 2018. The 50-foot-tall sculpture of a deer looking up to the sky, with an antler in its mouth is known as the Gateway to the Hamptons.
