29 Blood Pressure Monitoring This is a prevention program where the Organization provides free blood pressure monitors to children impacted by kidney disease and to the parents of children with health issues, such as obesity, kidney conditions, and diabetes. The blood pressure monitoring program is designed to help in the prevention, diagnosis, and early treatment of hypertension and kidney problems. Approximately 15% of the children receiving the monitors have chronic kidney disease and are very close to being on dialysis, are on dialysis, or have had a transplant and must monitor their blood pressure to maintain their health and keep their transplants. The remaining 85% of the children who receive the monitors are at risk of kidney disease due to obesity, diabetes, or hypertension and use the monitors to assist them in preventing kidney disease. The goal of the program is to assist those with chronic kidney disease in maintaining health, keeping transplants, and to assist kidney health professionals determine effective treatments for hypertension quicker, helping to prevent kidney disease in those children who are at risk.
