ASAP's Local Food Campaign, capacity building work gives farmers and buyers with the skills they need to succeed in promoting and developing our local food economy. The Appalachian Grown program provided farm planning and market development services to more than 900 farms and 450 businesses, and assisted 107 farmers markets to understand best practices, promote themselves, and navigate the regulatory environment. The program held its 15th annual ASAP Business of Farming Conference, delivering 15 workshops to more than 262 participants in 2018. ASAP's Local Food Campaign also builds interest in local farms and food in Western NC and the Southern Appalachians. ASAP published 50,000 copies of the Local Food Guide in 2018.

Form 990, Part III, Line 4b:

Our websites are cited by multiple farmers as a key source of customer traffic. The Appalachian Grown regional branding and certification program certified 900 farms. More than 450 businesses including grocers, restaurants, distributors, hospitals, colleges, and public schools participated in the program. Local Food Campaign organizers collaborated with farmers, restaurants, school systems, hospitals, and multiple grocers to develop point of purchase promotions and support use of the Appalachian Grown brand. ASAP's Farm Tour is an annual event connecting the public to their local farms and producers. Participating farms are open during one weekend to invite visitors to tour their farm and meet their family, and provide guided tours, demonstrations, and hands-on experiences. Every year, ASAP welcomes more than 1,000 participants to

the Farm Tour ASAP's Growing Minds program connects health and wellness programming with local agriculture. This program provides support and resources in order to create healthy food environments and experiences to better the health of all members of our community, including children, their parents, teachers and school staff. The program facilitated positive local food experiences through cooking demonstrations, farm field trips, gardens, and locally grown food served in school cafeterias to thousands of children throughout our service region. ASAP provides workshops, conferences, and other trainings to hundreds of professionals, so that they can integrate local food, healthy eating, and farm-based activities into their work. Funds were distributed to teachers and community health professionals, to facilitate the creation/maintenance of school gardens, provide cooking classes, or take farm field trips. Dietetic Interns from Western Carolina, University of North Carolina Asheville, and Lenoir-Rhyne University were trained in farm to school. The Local Food Research Center (LFRC) examines the social, economic, and environmental impacts of localizing food systems. The center researches and tests ASAP's theory of food system change. ASAP's theory is that creating democratic and responsive food systems will increase community well-being, build resilient economies, and support environmental sustainability. Closer connections and knowledge developed through food system experiences empowers citizens to consciously create a just and sustainable food system. In 2018, LFRC synthesized research data into several research reports and presented findings at two conferences - SARE's national Our Farms, Our Future conference and the regional Appalachian Studies Association conference. Research findings also informed programmatic work at ASAP. LFRC provided research framing and content support for the Local Food Guide, the Farm Tour Guide, the annual calendar, ASAP's annual report, the Growing Local weekly radio segment, and more. Research findings also supported ASAP's fundraising efforts, research staff provided content, framing, and writing support for several grants including two large multi-year grants that were later funded. LFRC also provided ongoing evaluation assistance to other ASAP programs and administered ASAP's annual survey to farmers, which informs the work of the Local Food Campaign.
