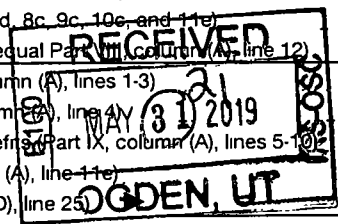

Longwood at Home served over 325 residents during 2018. Longwood at Home provided \$19,750 of community support in 2018 also.

As Western Pennsylvania's first and only continuing care at-home membership program, Longwood at Home was developed, and continues to be operated by Presbyterian SeniorCare.
