Total pastors affected are 30 touching the lives of 2,000 within the villages.

Travel to and teaching of indigenous pastors in training centers in Portugal and Guinea Bissau, Africa (a Portuguese speaking country). Biblical training was provided to 15 pastors who have congregations of 30 to 50 people touching over 600.

This person is a licensed marriage and family therapist.
