EDUCATION AND OTHER MCJ FILED AN AMICUS BRIEF IN SUPPORT OF THE SOUTHERN POVERTY LAW CENTER'S CHALLENGE OF CHARTER SCHOOLS BASED ON THE USE OF DISTRICT FUNDS IN VIEW OF A RISE IN BULLYING IN THE CLASSROOM, MCJ REVIEWED ALL SCHOOL HANDBOOKS FOR BULLYING POLICIES, AND DEVELOPED MODEL LANGUAGE TO ENSURE SOME UNIFORMITY STATEWIDE. WE HAVE MADE PRESENTATIONS ON STUDENTS' RIGHTS IN BULLYING SITUATIONS IN A NUMBER OF SCHOOL DISTRICTS. MCJ ALSO TOOK ON A SERIES OF DIRECT SERVICE CASES TO ENSURE STUDENT'S RIGHTS WERE PROTECTED. MCJ CONTINUES ITS CASEWORK TO PUSH FOR AN APPROPRIATE STANDARD OF PROOF IN SCHOOL DISTRICT CASES. AFTER DISCOVERING THAT A SCHOOL DISTRICT WAS NOT PROVIDING REQUIRED TRANSPORTATION TO ALTERNATIVE SCHOOL, MCJ GOT THAT SCHOOL DISTRICT TO COMPLY WITH THE LAW AND THEN IDENTIFIED OTHER DISTRICTS WITH THE SAME PROBLEM. MCJ ADDRESSED THE ISSUE WITH THE STATE BOARD OF EDUCATION. MCJ ALSO REPRESENTED A BLIND STUDENT WHO WAS DENIED EQUAL ACCESS TO TEXTBOOKS AND SUCCESSFULLY GOT SCHOOL DISTRICTS TO CHANGE THEIR HANDBOOKS TO COMPLY WITH TITLE IX AND STATE BULLYING PROVISIONS. IN ANOTHER CASE, MCJ GOT A YOUTH COURT ORDER DISMISSING THE DISTURBING THE PEACE CHARGE STATING THE SCHOOL SHOULD HAVE HANDLED IT UNDER IDEA AND/OR STATUTE RELATING TO STUDENTS MCJ, IN PARTNERSHIP WITH ACLU AND LOCAL PARTNERS UNDERTOOK A PROJECT IN SUNFLOWER COUNTY TO CHANGE EXISTING DISCIPLINE PRACTICES, STRENGTHEN RELATIONSHIPS BETWEEN SCHOOL OFFICIALS, LAW ENFORCEMENT (INCLUDING THE COURTS), AND PARENTS, AND TO CHANGE THE NARRATIVE ABOUT YOUNG MEN OF COLOR. THE SECOND YEAR OF THE PROJECT INVOLVES IMPLICIT BIAS TRAINING FOR SCHOOL PERSONNEL AND ANALYSIS OF DISCIPLINE STATISTICS. PUBLIC BENEFITS MCJ HIRED A POLICY ASSOCIATE AND STAFF ATTORNEY TO WORK ON FOOD JUSTICE ISSUES. OVER THE NEXT THREE YEARS, THEY WILL BE WORKING ON SNAP ISSUES, BOTH FROM A REGULATORY STANDPOINT AND FROM THE GROUND LEVEL, COLLECTING STORIES FROM SNAP RECIPIENTS ABOUT THEIR EXPERIENCES WITH THE PROGRAM AND MONITORING DHS'S IMPLEMENTATION OF SNAP. THEY WILL HELP ORGANIZE A COALITION OF PEOPLE WORKING ON FOOD JUSTICE ISSUES AROUND THE STATE AND ORGANIZE AT LEAST ONE ANNUAL CONVENING. THEY WILL ALSO BE AVAILABLE TO DO GENERAL PUBLIC BENEFITS ADVOCACY FOR MCJ. MCJ SUBMITTED A CROSS-CAMPAIGN DETAILED COMMENT TO THE FEDERAL GOVERNMENT'S PROPOSED PUBLIC CHARGE RULE, WHICH WILL SEVERELY HAMPER IMMIGRANTS' ACCESS TO BENEFITS THEY'RE ENTITLED TO. WE ARE ALSO CLOSELY TRACKING THE FARM BILL IN CONGRESS AND COMMUNICATING WITH OUR DELEGATION TO KEEP ENHANCED WORK REQUIREMENTS FOR SNAP OUT OF THE FINAL BILL. MCJ CREATED FOOD SECURITY POLICY ONE-PAGERS ON FOOD WASTE, COTTAGE FOOD LAWS, SNAP USAGE FOR DISTRIBUTION TO LEGISLATORS AND OTHER ADVOCACY GROUPS. MCJ HOSTED A MEETING FOR LEGISLATORS TO BEGIN DISCUSSING THE FORMATION OF A HUNGER CAUCUS IN THE LEGISLATURE AND TO STRATEGIZE ABOUT THE POSSIBILITY OF PASSING LEGISLATION REMOVING THE LIFETIME BAN ON SNAP FOR PEOPLE CONVICTED OF DRUG FELONIES. OTHER WORK IN EXPUNGEMENT, AN MCJ ATTORNEY CONDUCTED CLINICS AND REPRESENTED INDIVIDUAL CLIENTS. MCJ SCHEDULED BUS TRIPS FOR HIGH SCHOOL JUNIORS AND SENIORS FROM AROUND THE STATE TO THE MISSISSIPPI HISTORY AND CIVIL RIGHTS MUSEUMS. WE HAVE FUNDS TO SEND 105 BUSES TO THE MUSEUMS THIS SCHOOL YEAR, EACH TRIP WILL BE GUIDED BY A VETERAN OF THE CIVIL RIGHTS MOVEMENT. OUR IMMIGRATION ATTORNEY SUPERVISED STUDENTS AT MC LAW SCHOOL, WHO EACH DEVOTED 150 HOURS THIS SEMESTER TO HER IMMIGRATION CLINIC. SHE ATTENDED THE FIFTH CIRCUIT BAR ASSOCIATION APPELLATE CONFERENCE IN NEW ORLEANS AND HAS MADE SEVERAL PRESENTATIONS ABOUT IMMIGRANTS' RIGHTS IN THE COMMUNITY. SHE ASSISTED WITH AN AMICUS BRIEF TO THE FIFTH CIRCUIT CONCERNING A CITIZEN'S RIGHT TO APPEAL AN IMMIGRATION COURT DECISION IN COMMUNITY ENGAGEMENT AND COLLABORATION, MCJ CONTINUED TO HOST AND SERVE AS THE FISCAL AGENT FOR THE SUNFLOWER COUNTY UNITED FOR CHILDREN FOR THE FIRST HALF OF THE YEAR, A COLLABORATION THAT ADDRESSES COMMUNITY HEALTH, JOB READINESS, AND ENTREPRENEURSHIP. IMPACT LITIGATION PROJECT MCJ'S GEORGE RILEY IMPACT LITIGATION PROJECT WAS BUSY WITH A VARIETY OF CASES INVOLVING DEPRIVATION OF RIGHTS - MCJ TRIED A CASE AGAINST A COUNTY CORONER AND BOARD OF SUPERVISORS FOR DISCRIMINATING AGAINST AFRICAN AMERICAN FUNERAL HOMES, THE CASE SETTLED WITH A FAVORABLE CHANGE IN POLICY. - IN A SUIT AGAINST THE STATE OF MISSISSIPPI, MCJ AND THE CENTER FOR REPRODUCTIVE RIGHTS WON A PERMANENT INJUNCTION IN THE FEDERAL DISTRICT COURT AGAINST A 15-WEEK BAN ON ABORTIONS. THE CASE WILL BE APPEALED TO THE 5TH CIRCUIT COURT OF APPEALS. - MCJ WON THE RIGHT FOR PRISONERS TO RECEIVE READING MATERIALS OF THEIR CHOICE IN TWO SEPARATE LAWSUITS, BOTH OF WHICH SETTLED FAVORABLY SHORTLY AFTER BEING FILED. - MCJ HAS JOINED THE MS ATTORNEY GENERAL'S OFFICE IN SUING STUDENT LOAN SERVICERS FOR IMPROPERLY STEERING BORROWERS AWAY FROM FAVORABLE REPAYMENT OPTIONS. - ALONG WITH THE LAWYERS COMMITTEE FOR CIVIL RIGHTS UNDER LAW, MCJ HAS CHALLENGED THE LINES OF A SENATE DISTRICT THAT GOES THROUGH 6 COUNTIES AND FAILS TO GIVE AFRICAN AMERICANS THE OPPORTUNITY TO ELECT THEIR CHOSEN CANDIDATE IN AN AREA THAT SHOULD BE A MAJORITY AFRICAN AMERICAN DISTRICT. - IN A CASE FILED ON BEHALF OF EX-FELONS WHO HAVE BEEN DENIED THE RIGHT TO VOTE UPON REENTERING SOCIETY DUE TO A DISENFRANCHISEMENT PROVISION IN THE 1890 MISSISSIPPI CONSTITUTION, BOTH SIDES FILED MOTIONS FOR SUMMARY JUDGMENT WHICH IS PENDING BEFORE THE COURT. - ALONG WITH LAMBDA LEGAL, MCJ SUE A FUNERAL HOME FOR LGBT DISCRIMINATION IN FAILING TO HONOR A FUNERAL CONTRACT. - ALONG WITH THE SOUTHERN POVERTY LAW CENTER, MCJ SUE A SHERIFF'S OFFICE FOR RACIAL PROFILING IN DETAINING A FAMILY FOR FOUR HOURS FOR LOOKING HISPANIC WHILE TRAVELING THROUGH MISSISSIPPI.

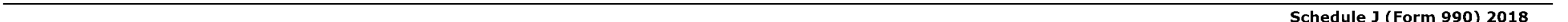
