To equip teams who are translating the Bible into minority languages with resources and tools in the appropriate LWC and provide training in how to use them effectively for translation and checking. This work also gives us valuable feedback to improve our tools and resources and make them more effective for the OL translation teams.

Working in collaboration with Bible translation agencies from the USA and with Bible translation and church planting agencies in India, we trained and equipped Indian personnel to translate and check New Testaments (NTs) in 12 Other (Minority) Languages (OLs) of North India. Jan 23-Feb 3, 2018 we conducted a training event for Indian Quality Checkers (QCs) who worked closely with the translation teams, under the supervision of Translation Consultants who continued their training on the job at checking events that we held in India April 11-30, 2018, June 16-30, 2018, and Aug 13-24, 2018. We continued interacting with the QCs over the internet through the rest of 2018, helping them check the 12 NTs and prepare them for recording and printing in 2019. With this training as a basis, many of the QCs are continuing to help other OL translators check the quality of their Bible translations.
