Form 990, Part III, Line 4a:

At our October 25th Public Meeting we secured a public commitment from a representative of Governor Cuomo's office to move crucial services of the NYS Office for People with Developmental Disabilities (OPWDD) out of the crumbling West Seneca facility where they are currently housed (three miles from the nearest bus line on the site of a former residential institution), to an accessible location on a public transit stop in the City of Buffalo within one year. The OPWDD will convene a committee of people with disabilities to oversee the moving process and ensure that the changes meet their community's needs.

Form 990, Part III, Line 4b:

We trained more leaders than ever before in our organization's history. We sent 49 community members to a four-day Faith in Action Regional Leadership Training, where they were trained in community organizing, 1:1 relationship building, and leadership skills. These leaders returned to Buffalo energized and excited to participate in our organizing work. We also trained an additional 50 leaders in cutting issues and planning actions at a day-long local training session.

Form 990, Part III, Line 4c:

We established two Peace Hubs within the City of Buffalo, which hold monthly Peace Circles and train community members in restorative justice. These Peace Hubs are now fully equipped to address conflicts in the community where harm has occurred, repairing the harm, resolving tensions peacefully, and re-integrating offenders into their community with support instead of funneling them into the criminal justice system.
