Each year, Baseballtown Charities helps to raise money for other charitable organizations that help underprivileged and disadvantaged youth and their families in Reading and Berks County. This money is raised through gaming with raffles and silent auctions of baseball-related merchandise or memorabilia provided by the Reading Fightin Phils, or through the Toss-a-Ball contest, all raised at the Reading Fightin Phils' home games.

4b (Code:) (Expenses \$ 129,801 including grants of \$ -0-) (Revenue \$ 110,430)

In April 2018, Baseballtown Charities completed the construction of the Dream League field to give those with physical and mental disabilities the same chance to enjoy the game of baseball as those able-bodied players every day across the country. Traditional baseball fields are not designed for those with special needs. The Dream League field is a custom-designed turf field that accommodates wheelchairs and other assistive devices while helping to prevent injuries. The spirit of the Dream League allows developmentally-challenged children to thrive, without the competitive burdens of traditional teams and leagues.

In December 2018, Baseballtown Charities undertook a new challenge to help individuals showing promise in the sports of baseball and softball improve their skills. Rip It For Life selects kids that may not have the economic wherewithal to get top notch baseball and softball training. We identify players who have the desire to be better, but would not otherwise have access to the type of instructors and facilities that Rip It Batting Cages can provide. We give these players a chance to be better, on the field and off. And off the field, Rip It For Life can provide an additional shoulder to lean on when necessary. Rip It For Life believes socio-economic challenges should not be an impediment to their journey to be better players and better people.

With the exception of Lauer's Park Elementary School and Olivet Boys & Girls Club, all other organizations are supported by fundraisers held at the Reading Fightin Phils Minor League Baseball home games. Records are kept of the amount raised and any costs associated if it is a raffle or silent auction, and the organization received the net proceeds of the fundraiser. Berks County Community Foundation is our choice of 501(c)(3) to receive the net proceeds of the 50/50 drawings as required by Pennsylvania law. Both Lauer's Park Elementary School and the Olivet Boys & Girls Club are the recipients of a \$5,000 grant each year as part of our ongoing agreement with these entities to build a ballpark at the school so inner-city youth would have a place to play baseball, and also learn about what does on in putting on a baseball game, the business aspects of baseball. The ballpark has a press box, concession stand, and a grandstand, in addition to the field. Funds are required annually to keep up the maintenance of the field in the ballpark. Olivet Boys & Girls Club sponsors the RBI League at the stadium at Lauer's Park Elementary School and their annual \$5,000 grant is used to provide uniforms for the kids.

The Dream League field is a custom-designed turf field that accommodates wheelchairs and other assistive devices while helping to prevent injuries. The spirit of the Dream League allows developmentally-challenged children to thrive, without the competitive burdens of traditional teams and leagues.
