The Foundation is a small, totally volunteer organization, based in Montgomery, Alabama. Since 2011, the Foundation has sponsored mission work at Cambridge University. In 2014 the organization expanded to London and Edinburgh. The total number of missionaries in the UK David and Sarah Illman, Peter and Ilona Greyling, Jon Thompson and Andrews Fellowes. These servants conduct seminars tours and lectures and edit and distribute publications. The Foundation now has a summer program to provide further educational opportunities for students to more fully explore the broad heritage of the Christian faith and the influence individual Christians had on the development of Western thought and culture. The work in Cambridge can be seen at www.christianheritage.org.uk. The Foundation also supports the Round Church which is the site for seminars, tours, bible studies, lectures and other classes for university students and scholars. The topics of the seminars are varied but all activities center on faith and the impact of the Christian Religion had on scholars and scientists and the significance of faith in everyday life. Since 2012, a number of organizations based in the UK have partnered with the Foundation to act as fiscal agent to accept grants and donations to support other mission projects. Donors in the United States count on the Foundation to accept funds and remit them to other organizations sharing the same mission, but utilize different methods to achieve their goals. Due to the small size of the Foundation the costs involved and the desire to maximize funds to accomplish the mission of the Foundation, no audit is conducted. Donors give to the Foundation and the funds are transferred on a monthly basis to support the work of the missionaries and the program they conduct. The missionaries work under the law of the UK (and EU) and the Foundation makes no attempt to verify compliance with those laws. While churches and a few qualified organizations do make contributions, the vast majority of support comes from individuals making monthly gifts. Such donations are properly receipted annually. The organization maintains one bank account and has no endowment, investment account or other assets. Form 990 has many questions that simply do not apply to such a small, volunteer organization. The Foundation has not paid employees and the officers and directors give of their time without any remuneration. Expenses are kept low so that the bulk of the funds donated can support the Foundation's mission. Every effort has been made to provide proper and direct information responsive to the questions listed on the 990. In 2016, the Foundation was audited by the IRS with no material issues. Many of the questions listed on the 990 do not apply and could not apply to this organization. In 2015, the organization did receive a 25% interest in an LLC, but not funds or other income was generated for the benefit of the Foundation. Once the LLC is sold, income should be realized and will be properly documented and filed. Schedule K-1 is attached for informational purposes to disclose the LLC interest.
