Grant applications are accepted for projects or programs in five focus areas: Arts & Culture, Education, Family, Environment, Recreation & Preservation, and Health & Wellness. Separate committees review and evaluate the applications to select finalists. 100% of member's (or shared member) \$1,000 annual donation is awarded to that year's grant recipients.

In 2018, we awarded 5 - \$100,000 grants and 5 - \$10,000 grants

Each organization chosen for a grant is assigned a grant liaison whose focus is to monitor the project progress and expenditures. The grant liaison is responsible for the completion of all forms to be completed by the grant recipients. The grant liaisons report to the Grant Outcomes & Oversight Chair, who in turn is responsible to the Board of Directors, to keep them informed of the status of the project, approve that the reimbursement requests are in keeping with the grant submittal and ensure that copies of all supporting documentation are submitted with the reimbursements, first to the Board Vice President (Operations) for approval and then to the Treasurer for payment. The Grant Outcomes & Oversight Chair provides the full board a monthly progress report on the awarded projects and expenditures. Awardees must submit periodic reports on the implementation and project progress to the grant liaison, per contract. All awardees must expend their funds within 24 months of the grant contract being signed.
