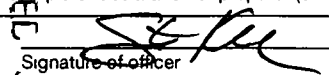

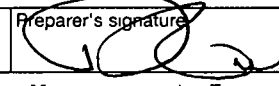

The project began in 2011 as a collaboration between the Abundance Foundation and Harvard Graduate School of Education's Project Zero. The Abundance Foundation received grant funding from the Harvard Graduate School.

He provides clinical expertise and on-the-ground engagement with the Foundation's Health program partners and represents the Foundation in various venues.
The Abundance Foundation supported the Global Pediatric Alliance to improve maternal and infant health in Mexico and Central America in 2018 by funding the capacity building of their small grants program. This grant program supports
