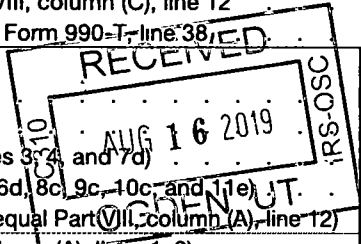

Two bands perform live on stage while roving minstrel singers perform throughout the festival grounds and the town of Marcus Hook. Food vendors, crafters, various inflatable bouncers and slides, pony rides, fire engine rides, train rides and carnival games are provided for family entertainment
