Part XI, Line 2d: We are modifying a portion of revenue recorded on an accrual basis to allow for better matching of the income to the periods in which it will be used for patient funding. In 2016, the Organization was notified by a foundation of a grant of \$250,000 (paid in December 2016) to be used for patient funding of \$125,000 in each of 2017 and 2018. Per the requirements of generally accepted accounting principles using the accrual method, in 2016 we recorded revenue and the related cash of \$250,000 for this grant. However, since we wouldn't use these funds until 2017 and 2018, for purposes of the 990, we deferred the \$250,000 and have shown it as \$125,000 in each of 2017 and 2018 in order to match it to the periods in which it will be used for our primary program services. Similarly, in December 2017 we received another \$500,000 grant to be used for patient funding in 2018 and beyond. We have deferred this and will show it on the 990 in 2018 and following to match it to the periods in which the expenses are incurred. Thus, there are 2 adjustments: adding \$125,000 from the 2016 accrual for funds used in 2018 and adding \$150,000 from the 2017 \$500,000 deferral for funds to be used in 2018 and beyond. The net effect of these two adjustments is to increase accrual-basis income by \$275,000. This results in the amount of income actually available in 2018 for 2018 patient funding, which we feel provides better information with regard to when the funds can be used.

Our organization's mission is to aid seriously ill patients and their families with non-medical expenses related to a hospitalization stay, such as meals, parking, housing, etc. We

work with social workers from various hospitals in the Texas metropolitan areas to identify patients with such needs and provide funds ranging from \$50-\$500 per patient, depending

on needs. Funding is given to patients in various forms, such as cash, Visa or Wal-mart gift cards, hotel payments, hospital parking chips, etc., so not all awards are given out

in cash but all are directly valued at their cost (gift cards have a stated value, parking chips have a certain associated \$ amount, etc.); no discretion must be used in valuation.

An application is submitted to the organization by each patient desiring funds, and the application goes through an approval process. Each approved application is logged and

funding is recorded, so we are able to track the number of patients helped. In 2018, we provided assistance to 740 recipients with a total of \$228,599 in funding, which

is an average of \$309 per recipient; however, as stated previously, each patient may receive a different amount generally limited to \$500 maximum per patient depending on need.

Our 2018 funding was down compared to 2017 due to updating systems to be HIPAA compliant with respect to encryption and security, but 2019 is expected to be much greater.

In 2016, Compassionate Touch was notified by a foundation of a grant of \$250,000 paid in December 2016 to be used for patient funding of \$125,000 in each of 2017 and 2018. In accordance with generally accepted accounting principles using the accrual method, we recorded revenue/receivable of \$250,000 (then the cash in Dec.) in 2016 for this grant. However, since the funds were for use in 2017 and 2018, for purposes of the 990, we deferred the \$250,000 in 2016 and have shown it as \$125,000 in each of 2017 and 2018 in order to match it to the periods used for our primary program services. We believe this provides a more representative picture of our revenue available for funding in 2016-2018. Similarly, on December 27, 2017, we received a donation of \$500,000, which was not available for use in 2017 and will be used for patient funding in 2018 and future years. Like the 2016 grant, for accrual-basis financial statements, the 2017 grant was recorded in 2017, but for this 990 it has been deferred and will be shown as income in 2018 and later years in order to match it to the year in which the funds will be expended. In 2018, \$150,000 of the \$500,000 grant was used for patient funding operations. As an added note, this impacts the amount reported in Schedule B for these contributors as Schedule B reflects the same method used in this 990 as required.

Form 990, Page 12, Part XII, Line 1 - For "Accounting method used to prepare the Form 990" we checked "Other" only due to the departure from the accrual basis method discussed above for the two major grants in 2016 and 2017. Other than that, this Form 990 has been prepared on the accrual basis and is in agreement with our independently audited financial statements. We believe the modifications made for this 990 result in a more robust and complete picture of the operations of Compassionate Touch for 2018.
