THE ORGANIZATION WAS ACTIVE AT THE LEGISLATURE ON TAX REFORM, FREE SPEECH AND OCCUPATIONAL LICENSING REFORM. DUE TO OUR EFFORTS, THE ORGANIZATION WAS SUCCESSFUL IN PASSING LEGISLATION TO LIMIT THE AUTHORITY OF STATE BOARDS AND COMMISSIONS TO CONSIDER PRIOR CONVICTIONS WHEN REVIEWING LICENSING APPLICATIONS. THE ORGANIZATION ALSO PASSED LEGISLATION GRANTING CITIZENS THE RIGHT TO MANDATE A REVIEW OF ANY APPROVED RULE OR REGULATION TO DETERMINE THAT IT DOES NOT EXCEED AN AGENCY'S LAWFUL AUTHORITY AND THAT IT IS CONSTITUTIONAL. THE ORGANIZATION ALSO AMENDED STATE LAW TO MAKE IT CLEAR THAT MUNICIPALITIES ARE PROHIBITED FROM REQUIRING THE DISCLOSURE OF DONORS BY ANY NONPROFIT ORGANIZATION. THE ORGANIZATION ENGAGED IN AN EXTENSIVE EDUCATIONAL CAMPAIGN WITH LAWMAKERS TO EXPLAIN THE TAX CUTS AND JOBS ACT AND HOW IT WOULD IMPACT ARIZONA'S INDIVIDUAL AND CORPORATE INCOME TAX CODE.

THE ORGANIZATION ACTIVELY OPPOSED A BALLOT MEASURE THAT WOULD DOUBLE THE STATE INCOME TAX. THE ORGANIZATION PARTICIPATED IN SEVERAL FORUMS AND PRODUCED RESEARCH SHOWING THE ECONOMIC DAMAGE THE TAX INCREASE WOULD HAVE ON ARIZONA'S ECONOMY. THE ORGANIZATION ALSO PARTICIPATED IN THE LEGAL COMPLAINT AGAINST THE MEASURE, WHICH RESULTED IN THE INITIATIVE BEING REMOVED FROM THE BALLOT DUE TO DEFECTS WITH THE LANGUAGE. THE ORGANIZATION ALSO OPPOSED THE MEASURE TO MANDATE DONOR DISCLOSURE BY ALL NON-PROFIT ORGANIZATIONS. THE ORGANIZATION WAS A PARTY TO THE LAWSUIT CHALLENGING THE VALIDITY OF THE PETITIONS, WHICH RESULTED IN THE REMOVAL OF THE MEASURE DUE TO A LACK OF SIGNATURES.

THE ORGANIZATION SUPPORTED AN EFFORT TO REFER A MEASURE TO VOTERS PROHIBITING THE USE OF TAXPAYER MONEY TO FUND POLITICAL PARTIES THROUGH THE CITIZENS' CLEAN ELECTION COMMISSION. THE ORGANIZATION SUPPORTED A LENGTHY VOTER EDUCATION CAMPAIGN PROVING THAT OVER \$100,000 WAS FUNNELED TO POLITICAL PARTIES THROUGH CLEAN ELECTIONS, AND THAT ABUSE OF THE PROCESS OCCURRED DUE TO A LACK OF OVERSIGHT. THE MEASURE TO PROHIBIT FUNDS TO POLITICAL PARTIES WAS APPROVED BY VOTERS AT THE 2018 GENERAL ELECTION.
