Friends of Warm Hearth provides community-based, long-term group homes which prevent orphaned adults with disabilities and/or mental illnesses from being forced to live in psychiatric institutions in Armenia. We initiated a movement towards privatized forever homes and serve as a model for future group homes in Armenia for the benefit of this vulnerable population.

In 2018, we provided ongoing long-term residential care to fourteen residents in Warm Hearth 3rd Village. In addition, we opened a second home (Warm Hearth Arinj) to provide long-term residential care to eight residents in May of 2018. In both homes, we continued and/or initiated programs to encourage the social, physical, mental, spiritual and vocational well-being of our residents. Through weekly programs and through the expertise of our staff, we have facilitated community and societal integration. Resident life interviews, Individual Care Plans, Positive Behavior Support Plans, and Monthly Progress Notes include data from the International Classification of Functioning, Disability and Health, continue to serve our residents and provide quantifiable data in regard to growth, well-being and the development of our residents.
