THE DCCF IS THE ONLY CENTRAL, COUNTY-WIDE RESOURCE TO HIGHLIGHT NEEDS IN THE COUNTY, WORKING TO IDENTIFY AND INSPIRE LOCAL DONORS, SUPPORTING THE NEEDS OF LOCAL NONPROFITS, AND MATCHING DONORS WITH EFFECTIVE LOCAL NONPROFITS - ALL TO IMPROVE THE QUALITY OF LIFE FOR EVERYONE LIVING IN DOUGLAS COUNTY. IN 2018, THERE WAS A 18% INCREASE IN MEMBERSHIP IN DOUGLAS COUNTY GIVES, A PROGRAM THAT BRINGS NONPROFITS TOGETHER TO PROMOTE AWARENESS OF THE WORK THEY ARE DOING, A 40% INCREASE IN THE NUMBER OF VOLUNTEERS HELPING THE WORK OF DCCF, AND A 57% INCREASE IN THE SIZE OF THE GOVERNING BOARD.
