One South African missionary has planted a church in CA. Another from London is a residential volunteer in MN who lives with & ministers to women survivors of prostitution & exploitation. One missionary couple builds schools (six to date) in Zimbabwe & provides for the feeding of hundreds of children there each day. Another couple is reaching millennials with the truth of the gospel. Many other missionaries do great things for multitudes with little more than their own perseverance, our encouragement, & our faithful support.

Our work in Ghana and Kenya, Africa focuses on providing resources & education for children & pastors. This year we began construction of our second elementary school in remote northern Ghana. This school will not only provide children a way out of poverty, but will also provide adult education & serve as a community center. We provided school supplies, curriculum, & equipment for the 150 children in the school we built last year in Navrango, Ghana. We sponsor Bible Outreach in the communities around Navrango. Our monthly support of Ghana pastors includes fuel, transportation, & equipment for 120 small groups which meet 2X per week to listen to the Bible on mp3 players. We have shown the Jesus film many times & hundreds have come to Christ in Africa. We support pastors in Eldoret, Kenya with resources & funds. These funds are used to evangelize, plant churches, train leaders, support orphans, & feed the poor in remote eastern Kenya.

Our work in India among the poor & lowest cast is from great need. This year we raised the funds to purchase & dedicate a piece of land for the construction of a new church in Andhra Pradesh, India. We also provided the construction funds.
