Haiti Bible Training Center. Through the operation of the Haiti Bible Training Center, our core function in Haiti is to bring in young men from different provinces of Haiti in order to disciple them through the Word of God, taking them through the bible over the course of two years in order to send them back out to plant churches in order to provide bible teaching, discipleship to their community. Each church plant is a community center where education to the poor, homeless, widows and orphans of Haiti are given.

The Missionary Training Center (MTC) is the Cross to Light campus that safely accommodates volunteer teams, constructs support projects, conducts conference events and special training workshops. Outreach events such as VBS, orphanage visits, prison outreach, soccer events, water projects and medical day clinics are all conducted out of this campus.

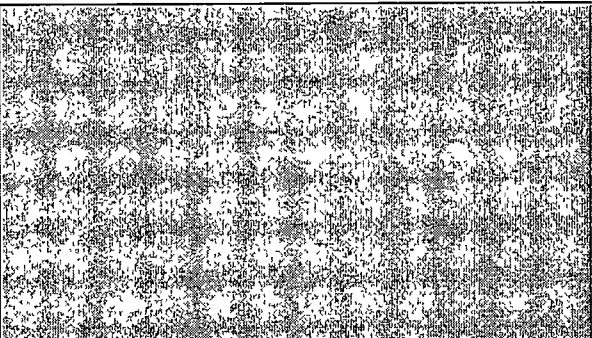
