Nonprofit VOTE (NPV) worked in 2018 to engage nonprofits on voting and elections. We hosted 14 free webinars reaching 3,000 nonprofit staff with legal how-to's, best practices, and planning tools. To deepen our reach, we worked with major groups like the YMCA, Goodwill, National Urban League, Food Resource Action Center, and others to develop voter engagement toolkits and campaigns for their respective networks. We developed a similar toolkit for private and community foundations in partnership with the Council on Foundation and Independent Sector. Through our States Program, we worked with partners across six states to register or pledge to vote 14,000 individuals. The data from that program was used as part of our Engaging New Voters report released in early 2019. Finally, Nonprofit VOTE recruited over 400 nonprofit partners for National Voter Registration Day 2018. With the NPV share of administration and development costs, total expenses come to \$521,317.

National Voter Registration Day (NVRD), a collaborative event managed by Nonprofit VOTE, is a single day of coordinated media and field actions to raise awareness about the registration process and help eligible voters get registered. We shattered records in 2018 with 55 major national partners and 4,000 community partners who collectively helped 865,000 voters register or update their registration. The event generated 33 major national news stories, thousands of local news reports, and 2.6 million social media engagements. We provided online toolkits and legal guides to partners, hosted 3 webinars that drew over 1,000 attendees, and mailed all partners organizing kits with event posters and stickers. Work also included post-event data collection, reporting / evaluation, and initial planning for 2019. With the NVRD share of administration and development costs, total expenses come to \$429,717.
