SINCE 2007, LIVING GOODS HAS BEEN SAVING AND IMPROVING LIVES IN RESOURCE-CONSTRAINED COMMUNITIES BY FACILITATING ACCESS TO COST-EFFECTIVE, QUALITY EDUCATION, DIAGNOSES, TREATMENTS, REFERRALS AND FOLLOW-UP CARE FOR BASIC HEALTH CHALLENGES FACILITATED BY CUTTING-EDGE TECHNOLOGY AND A CADRE OF MOTIVATED AND SUPERVISED COMMUNITY HEALTH WORKERS. CURRENTLY ACTIVE IN UGANDA AND KENYA, LIVING GOODS-SUPPORTED CHWS ARE PROVIDING BASIC HEALTHCARE TO MORE THAN 6 MILLION PEOPLE. A RANDOMIZED CONTROL TRIAL IN UGANDA SHOWED THAT LIVING GOODS' APPROACH TO COMMUNITY HEALTH REDUCED CHILD DEATHS BY 27% FOR LESS THAN \$2 PER PERSON ANNUALLY.

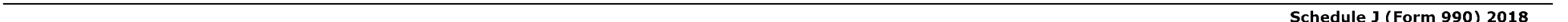
