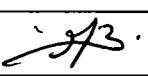

Maintained an art gallery open to the public and accessible to artists of all levels. The gallery has an open submissions policy and accepts works from beginners as well as accomplished artists. Generally, at any given time, the works of more than an hundred artists are on display throughout the year. Three times during the year the entire display was removed and replaced with new submissions and a Saturday evening art opening with music and community potluck was held. An estimated 200 persons throughout the evening visited at each of these art openings. Aprox. 250 persons per month visit the gallery during non-event hours.

Maintained an arts Center consisting of secondary, ~~art~~ auxiliary art gallery, artist work spaces, and facility for live presentations. Various live events, music, & presentations were held throughout the year. An average of 2 per week with estimated avg. attendance of about 100 ~~per week~~ persons per week. About 15 artists, artists in development, and organizers of arts related activities occupied studios/workspaces throughout the year. The arts center participated ~~by~~ in Tucson Community "ARTS WALK" and "OPEN STUDIOS TOUR" events. We do not have statistical data on attendance during these open house events.

NOTE: The arts center was closed at the end of 2018. Our intention is to focus on the main gallery.

PART III, LINE 30:

Held 32 live shows/events in our main gallery, featuring music. Estimated attendance for the year was 1400.

ADDITIONAL INFORMATION:

We are an art gallery and arts center dedicated to bringing the arts to the community. As a gallery & art center, the buildings are integral to our exempt activities. Ten percent of occupancy is allocated to operational expense.
