Education: Walking and biking education programs included: Youth 1-2-3 Instructor Training for adults. For youth, a Safe Walking and Biking Program was presented at 34 schools throughout the state and reached 3,748 students. This program is funded by the Safe Routes to School program and administered by NH Department of Transportation.

Safety: Worked with NHDOT to keep safety literature up-to-date.

Continued participation in several state safety commissions including the Highway Traffic Safety Committee and the State-wide Trails Advisory Committee

Worked with the Complete Streets Advisory Committee and partnered to present a Complete Streets Conference

Instrumental in securing passage of a new bicycle safety law for NH

4b (Code:) (Expenses \$ 12,259 including grants of \$ 5,500) (Revenue \$ 7,521)**BICYCLING RECYCLING PROGRAMS**

Bike-Walk Alliance of NH supports and encourages organizations to provide bicycles at low/free rates to persons who would like the opportunity to learn to cycle and/or need a bicycle as a mean of transportation. The number of organizations providing this outlet for affordable transportation increases yearly. BWANH supports this development and many of the organizations including QC Bike Collective and Ashland Recycles. Income from the sales is used to market the programs and provide funds to buy replacement parts and accessories. BWANH also serves as a statewide contact point for persons or organizations that would like to donate bicycles.

4c (Code:) (Expenses \$ 11,096 including grants of \$ 4,500) (Revenue \$)

Rail trail maintenance and development remains a major part of our mission. The Friends of Salem Bike-Ped Corridor worked with the town and state to complete "Phase 2" that now provides a 9.3 mile paved trail between Salem and Derry. The NH Rail Trails Coalition drafted SB-185 to update the 2005 State of NH Rail Trail Plan and perform an economic impact study to show the ROI of linked rail trails. All 29 NH rail trail groups are supportive of having the Coalition represent them as a state-wide voice seeking recognition and funding for non-motorized recreation and active transportation. All rail trail groups will be invited to the NHRTC conference in October 2019.
