The ABF follows policies and procedures designed to maximize the effectiveness of grants, as well as ensure the grant funds are used for an exempt purpose. These policies and procedures are applied consistently for grants in and outside the United States. All grants go through a pre-grant inquiry process where the grantee is required to provide extensive information on its governance practices, financial policies and program activities in general, as well as with regard to the specific program for which it is requesting funding. A formal grant agreement is then executed and countersigned by the grantee and the ABF. The grant agreement specifies the amount of the grant, grant disbursement time line, any restrictions on the grant, as well as that the grant funds must be separately accounted for by the grantee. Grantees must report back to the ABF prior to receiving release of periodic grant installment disbursements. The ABF usually makes grants in several installments to ensure compliance with program, operational and accounting requirements by the grantee organization. The grantees provide interim operational and financial reports to the ABF. The reports describe the progress in achieving the grant objectives and include detailed accounting of the uses or expenditures of all grant funds. The program directors and the evaluation team of the ABF review the interim reports and conduct site visits to ensure that the progress indicated in the reports is correct. The ABF Finance and Compliance function reviews the interim financial reports and supporting records, such as invoices and contracts. The grantees provide a copy of audited financial statements for the accounting period covering the grant, if such are available. The grantees also submit a written report summarizing the project within two months after completion of the project in which they include a complete account of the expenditures of the grant funds and detailed description of the results and accomplishments of the grant. The grantees are required to keep financial records with respect to each grant along with copies of any reports submitted to the ABF or at least two years following the year in which all grant funds are fully expended. The ABF Audit Committee and Board of Directors exercise oversight over the grants disbursed through the review of reports and presentations by management.

Grants are reported consistent with the ABF's financial statements using the accrual method of accounting. Grant expenditures are recognized in the period the grant agreement is signed by ABF and the grantee, provided the grant is not subject to future contingencies. Conditional grants are recognized as grant expense and as a grant payable in the period in which the grantee meets the terms of the conditions. If payments of the unconditional promise to give are to be made to a recipient over several fiscal periods and the recipient is subject only to routine performance requirements, a liability and an expense for the entire amount payable is recognized. Investment expenses are reported consistent with the ABF's financial statements using the accrual method of accounting.

Through its grants and programs, the Foundation represents the generous spirit of the American people and embodies the highest standards of US ethical conduct, transparency, and core values.

The America for Bulgaria Foundation was organized not for profit as a non-stock corporation under the General Corporation Law of the State of Delaware on December 18, 2006. The persons who serve on the Board of Directors (the governing body) of the ABF are the only members of the corporation.

The members of the corporation, who also constitute its board of directors, are entitled by the ABF's amended and restated certificate of incorporation to elect persons to the Board of Directors.

Part VI, Line 7b

Article Eight of the ABF's amended and restated certificate of incorporation provides that: "The Board of Directors of the Corporation shall be divided into three classes as nearly equal in size as is practicable, hereby designated Class I, Class II, Class III. The term of office of the initial Class I Directors shall expire at the next succeeding annual meeting of the Members, the term of office of the initial Class II Directors shall expire at the second succeeding annual meeting of the Members and the term of office of the initial Class III Directors

shall expire at the third succeeding annual meeting of the Members. The initial Class I, Class II and Class III Directors shall be those Directors designated as such in Article Ninth hereof. At each annual meeting of the Members, Directors to replace those of a class whose terms expire at such annual meeting shall be elected to hold office until the third succeeding annual meeting thereafter and until their respective successors shall have been duly elected and qualified. If the number of Directors is hereafter changed, any newly created directorships or decrease in directorships shall be so apportioned among the classes as to make all classes as nearly equal in number as practicable. The election of Directors need not be by written ballot. Any Director may be removed at any time, with or without cause, by a vote of a majority of the Members. Any vacancy occurring on the Board of Directors of the Corporation may be filled by a majority of the remaining members of the Board of Directors of the corporation, although less than a quorum, at any meeting of the Board of Directors of the Corporation. Any Director elected to fill any vacancy on the Board of Directors of the Corporation shall be elected to serve the unexpired term of the directorship".

Part VI, Line 11a, b

The Chief Financial Officer (CFO) is responsible for the preparation and the filing of the IRS Form 990 and all necessary extensions. The Form is completed by the Finance function of the ABF. As part of the preparation process, issues are discussed with outside legal and tax counsel and an external tax service consultant for nonprofit organizations. After a review by the CFO, copies of the Form are provided to the president and the executive director of the Foundation for their review and feedback. A copy of the Form is distributed to the members of the Audit Committee of the board of directors. During a scheduled meeting of the Audit Committee, the CFO reviews the Form with the Audit Committee and any necessary changes are made. Before the Form is filed, a copy of the approved Form is provided to all officers and directors for their comments. The Form is then finalized and signed by the president or the CFO. After filing with the IRS, a copy of the signed Form is distributed to all directors.

Yes. Each year the directors, officers, and employees of the ABF review the Foundation's conflict of interest policy, disclose any conflict not previously disclosed, and update the status of any previous conflicts of interest reported in prior periods. In addition, all directors, officers, and each employee annually sign a statement affirming that he/she has read the policy, agrees to comply with the policy, and acknowledges that he/she either is not aware of any violations or is disclosing therein any known violations.

The completed conflict of interest policy statements are reviewed by the CFO, Executive Director and President to determine whether

conflicts exist. Actual conflicts are reviewed with the Board of Directors.

No member of the Board of Directors of the ABF or any officer or management employee of the ABF shall originate, participate in, or vote on any transaction involving the ABF in which such person has a conflict of interest. In particular, a Director of the ABF shall recuse him/herself from the Board's deliberations regarding any matter in which the Director has a conflict of interest unless the Chairman of the Board determines that recusal is unnecessary in the particular instance. In addition, an employee shall not be the responsible staff person on a transaction in which he/she has a conflict of interest.
