Reformation Hope, Inc. continues to provide financial assistance to the Souls Winning Ministries New Joy House Orphanage in Marin, Haiti. This facility was expanded in fy2016 and an additional 15 children were added to the total being cared for, bringing the number to 78. The expanded orphanage will eventually house up to 100 children, although according to Haitian government regulations, the facility must keep 10% of its beds available for potential rescue children relocated from deficient orphanages elsewhere in the nation. In fy2018, the number of children cared for and educated through the orphanage was increased to 83.

4b (Code:) (Expenses \$ 86,696 including grants of \$ 86,696) (Revenue \$ 0)

The second largest expense/grant center for Reformation Hope, Inc. in fy2018 was financial assistance to Souls Winning Ministries in Haiti for the salaries of its director, asst. director, and New Joy House orphanage director. This assistance was also provided to assist Souls Winning Ministries in supporting an indigenous church leader for their new church and school in Jacmel, Haiti, located on the southern coast. A small portion of the total (\$1,766) was allocated for purchasing airline tickets for the Souls Winning Director to travel between the United States and Haiti for consultations and planning for projects in Haiti.

4c (Code:) (Expenses \$ 69,846 including grants of \$ 69,846) (Revenue \$ 0)

The new program service in fy2018 was the provision of funding to Souls Winning Ministries in Haiti for the purpose of remodeling their older compound facilities in order to accommodate the expansion of their primary school to include the secondary level through the 12th grade. This expansion and remodel required the addition of a second floor above the existing kitchen and dining hall space, as well as extensive repairs, repainting, and some furnishings. This grant also supported a small amount of local radio and street sign banner advertising for the new high school.

New Program Services not previously listed:

As detailed on Form 990, Part III, 4C, Reformation Hope, Inc. provided a total of \$69,846 to Souls Winning Ministries in Haiti:

The new program service in fy2018 was the provision of funding to Souls Winning Ministries in Haiti for the purpose of remodeling their older compound facilities in order to accomodate the expansion of their primary school to include the secondary level through the 12th grade. This expansion and remodel required the addition of a second floor above the existing kitchen and dining hall space, as well as extensive repairs, repainting, and some furnishings. This grant also supported a small amount of local radio and street sign banner advertising for the new high school.

Other Program Services (not detailed on Form 990, Part III):

4. Marin Medical Clinic: Reformation Hope provided grants totaling \$55,200 in supporting Souls Winning Ministries' Reformed Medical Clinic in the Marin/La Plaine area of Haiti, a suburb of Port-au-Prince, adjacent to Croix-des-Bouquets. The clinic serves the local community and specializes in assisting expectant mothers and their at-risk children, providing needed diagnosis and treatment. The clinic was instrumental throughout fy2018 as a dependable and professionally-staffed health care provider to the wider community during frequent periods of civil unrest and violence. Access to healthcare was provided, often with little or no cost, to those most in need.

5. Assistance to Replace a Primary Service Vehicle: Reformation Hope, Inc. provided financial support of \$38,200 to our Haitian partner organization, Souls Winning Ministries, for the purpose of replacing their increasingly unsafe primary vehicle with a late model used SUV, which was being deacquired by the United Nations MINUSTAH (Mission des Nations Unies pour la stabilisation en Haiti). The vehicle was placed immediately into service by Souls Winning Ministries and the funds granted were used to purchase, license, and insure the vehicle.

6. Mission Volunteer Teams: Reformation Hope assisted numerous mission teams in traveling to Haiti to volunteer in various projects and relief at Souls Winning Ministries' facilities and partner groups and individuals. This program cost was \$22,608 in fy2018. This represents a significant decline for fy2018 compared to fy2017 and other prior years. This is because the increasing instability in Haiti reduced the number of teams and individuals prepared to undertake such a trip.

7. Haiti Church Planting and Support. Reformation Hope dispensed grants of \$21,900 to Souls Winning Ministries in Haiti for their efforts to plant new churches, and also to provide much-needed furniture, repairs, improvements, etc. in poverty-stricken and often remote, rural areas of Haiti. This assistance also includes the costs associated with sending donated furniture via overseas shipping consolidator.

8. Souls Winning Ministries Staff Support. Reformation Hope provided grants totaling \$14,450 to Souls Winning Ministries for support of their staffing needs at the New Joy House Orphanage and other satellite locations.

9. Reformed Academy Bible College. Reformation Hope provided grants of \$10,546 in fy2018 assistance to Souls Winning Ministries' college level, Bachelor of Divinity and Bachelor of Theology training programs. This support also included the provision of a significant number of French and English language books suitable for the college's library in Marin, Haiti.

10. Specific Assistance to New Development in Jacmel: \$7,300 in fy2018 was provided to further the development of a strategic church plant and future community school proposed for Jacmel, on the south coast of Haiti.

11. Disaster Relief: Reformation Hope provided a total of \$5,300 in assistance to churches and families severely impacted by an earthquake in the northwestern part of Haiti, populated by persons connected to the Souls Winning Ministries projects.

12. Electrical Supplies: Reformation Hope assisted Souls Winning Ministries in improving their electrical supply to their orphanage, guest house, and medical clinic through the provision of \$1,000 for a large spool of '0' gage copper, sheathed electrical wire.
