Cliff Todd Endowment Grants were awarded to community based organizations that support, advocate for, and education about issues concerning lesbian, gay, bisexual, and transgendered citizens of Kentucky. Recipients of 2018 Grants were: PFLAG of Frankfort; Transylvania University; Pride Community Services; Bluegrass Black Pride; Imperial Court of Kentucky; University of Louisville Kent School of Social Work; University of Kentucky Gender & Womens Studies Program; Lexington History Museum; Kentucky Black Pride; Bluegrass Community & Technical College; The Faulkner Morgan Archive; The Association of Welcoming & Affirming Baptists; Kentucky Fried Sisters; the Woodford Theater; GLSEN; UK Prism Research; Unlearn Fear & Hate and the University of Kentucky Graduate Center for Gerontology. The projects that were funded ranged widely, from elder care studies, to public art performances, materials and resources for education, conferences and speakers, as well as advocacy.

This year our main public program was the unveiling of two Kentucky Historical Society markers in Lexington, Kentucky commemorating special locations where significant events occurred in the local history of the LGBTQ movement. The markers will help educate the wider community about the continuing struggle for acceptance, and the presence of LGBTQ people in the Central Kentucky area both historically and in modern times. By placing these markers and having a public unveiling ceremony, we both honor those who have gone before us and give hope to those in the present day that hurdles can be overcome. A number of prominent local speakers were part of the ceremony and this year's grant recipients were also honored at this event, providing awareness and advocacy for their missions which are helping to improve life for LGBTQ persons not just in Central Kentucky but also in rural and small towns of the state. Having activists travel to Lexington to meet with one another gives an opportunity for networking and communal problem solving. This event was well attended - over 400 - and was written up in the local newspaper.
