In 2018, the Vermont Studio Center continued its fourth decade by providing more than 725 artists and writers with the invaluable combination of studio time and space, international community, optional artistic counsel, and daily life along the Gihon River in Johnson, Vermont. Artists and writers came from nearly all 50 states (plus Washington DC and Puerto Rico), and more than 30 countries. An all-time high of 240 of the participating residents received Fellowships, while 421 received some form of partial financial assistance, for a total of 661 artists who received financial support. VSC completed and cut the ribbon on the second project of its Campus Master Plan (CMP), the Church Studios, which had been off-line and unusable by VSC since a serious June 2016 fire. In addition, VSC received a generous matching challenge of \$850K toward the third CMP project, the Pearl House. Scheduled to begin in October 2019, the restoration will create 14 individual resident bedrooms, and combine the historic stature of a landmark village home with all the efficiencies, safety, and accessibility of a modern building. In 2018, VSC began to set the stage for its 35th anniversary in 2019 with alumni events in VT, DC, Boston, Greenwich, NYC, LA, and Montreal, and a special fellowships campaign, 35 in 35 to inspire new fellowship donors. Strategic Planning continued in 2018 by bringing the board and staff together, under the guidance of a consulting facilitator, to re-affirm core values and set the goals and priorities for the next 3 years and beyond. As a parallel track, an on-going series of diversity and inclusion workshops supported staff in their effort to make VSC a welcoming place for all residents, employees, and volunteers. In its commitment to support the local community, the VSC School Art Program provided more than 225 local children with weekly art instruction and cultural enrichment, more than 100 public events were hosted by VSC in its historic former opera house on Main Street, and the VSC kitchen spent nearly a third of its food budget, or \$125,000, on locally-sourced agricultural products. In 2018, the Vermont Studio Center received 857 individual charitable contributions ranging from \$2 to \$290K in support of all aspects of VSC community life. The VSC Endowment Fund maintained its all-time high of more than \$8,200,000.

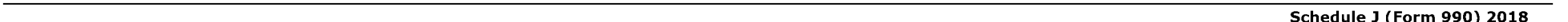
