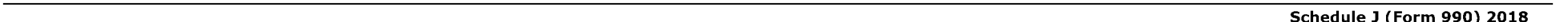

The organization continues to educate residents of New Jersey through the high school heroes program which teaches students in all public high schools in grades 9-12 about the importance of organ and tissue donation. There are many other education tools and outreach through mainstream media that inform the general public about the option to donate and of the benefits of transplantation. New Jersey is a first person authorization state, which means that once a person makes the decision that they would like to be a donor at the motor vehicle agency or through the on-line registry that wish is honored if they die in a manner that would allow them to be a donor. The Hero Act was designed to create a more dynamic and comprehensive public policy regarding organ and tissue donation. NJ Sharing Network offers a donor family support department, which provides care during and after a donor family's active hospital experience. The department also addresses unique issues related to seeking consent for organ and tissue donation. NJ Sharing Network enlists a large base of volunteers. These volunteers are the ambassadors for the organization as they educate the public and encourage them to register to become organ and tissue donors. Our transplant laboratory is a fully accredited "state of the art" facility performing histocompatibility testing of organ donors and recipients. The laboratory also plays a critical role in the pre and post-transplant evaluation, and successful transplantation of highly sensitized individuals who would be difficult to treat under general conditions. Maintained by a highly trained staff, the laboratory continues to play a key role in completing the circle of life. To date, the lab is credited with saving the lives of over 8,000 New Jersey residents.
