FAMILIES THAT ARE WILLING TO PARTNER WITH US CONTRIBUTE 400 HOURS OF SWEAT EQUITY HELPING TO BUILD THEIR HOME. IN ORDER TO HELP THE "PARTNER FAMILIES" BE SUCCESSFUL AS HOMEOWNERS, GMHFH REQUIRES THAT THE FAMILIES ATTEND FINANCIAL TRAINING WORKSHOPS AS WELL AS HOME MAINTENANCE TRAINING.
