Section A. Officer Compensation: Maine Women Lobby Education Fund serves as a common paymaster for Maine Women's Lobby (a 501c4 organization). The Executive Director's W2, filed by MWLEF, showed \$73,557, covering salary for both organizations. On Form 990, page 8, however, the total includes only the .65 FTE Director position at MWLEF. Note that Maine Women's Lobby reimburses 100% of its portion of salaries, taxes and fringe benefits to MWLEF. The two organizations are unrelated per IRS regulations due to having separate boards where there is no majority control of one organization over the other.

Form 990, Part X - Additional Information

Line 4. Receivables: MWLEF uses a modified cash basis. This line shows Receivables only from Maine Women's Lobby, a closely allied organization. The Lobby is a 501c4 organization that is not related, as explained above. The small Accounts Payable figure on the Balance Sheet is a tracking of accrued Retirement Benefit not paid as of year-end.
